REPORT ON 2015 CMA RESOLUTIONS AND HOUSE OF DELEGATES

In a conference call on 9/22/15, the CAPM Board of Directors adopted positions on selected resolutions. Testimony in favor of these positions was distributed, and posted online by Ron Hattis, Don Lyman, and Jessica Nunez de Ybarra prior to closure of CMA member input on 10/2/15. CMA Reference Committees then prepared reports based on the online testimony, usually including amendments. Those reports (rather than the original resolutions) were considered by the various delegations and then voted on by the full CMA House of Delegates. Our delegate (Ron Hattis) pursued support for CAPM positions at the CMA Specialty Delegation and House of Delegates (HOD), 10/15-18/15.

This report lists those positions and the final outcome of deliberations. All resolutions supported by CAPM passed in amended form, mostly by consent of the HOD. Resolutions initiated or specially endorsed by the CAPM Board are capitalized, and final wording is included in italics.

Resolved: That CMA recommend that the teaching about specific diseases or disease groups in medical schools include information on the epidemiology and the primary and secondary prevention of those diseases, including the roles of nutrition and lifestyle as relevant.

608. EXPOSURE TO SPECIALTIES IN MEDICAL SCHOOLS (Authored by Ron Hattis, endorsed by CAPM): SS. Passed with Ref. Committee amendments on HOD consent calendar.

Resolved: That CMA support that medical schools provide medical students with access to information about all recognized medical specialties, through a range of mechanisms including, but not limited to clinical rotations, online resources, physician mentors, and exchange programs with other medical school programs.
