Active resolutions before the CMA for review and comment:

Resolutions on COVID-19: Resolutions for 2020 were largely restricted to actions taken by the House of Delegates related to two Reports concerning the COVID-19 situation. Each report was followed by a series of “Recommendations” which constituted “Resolutions” for action. These resolutions are still under active review by the Board of Trustees for adoption later this year. CMA members may access the Reports and submit recommended edits - additions - subtractions to the Resolutions on CMA website.

Other resolutions: Resolutions other than those connected to the two Reports listed above are now under review by CMA Councils and the Board of Trustees for consideration in 2021 and are listed here.

NOTE that the first three digits of each entry designates the parent Council to which the resolution is directed (e.g., all 100 series numbers go to the Council on Science and Public Health) and the last two digits indicate the year in which the resolution was submitted for consideration.
