**AB 24 (Haney) Dem**

- Emergency response, opioid antagonist kits: Free opioid antagonist kits to be available at bars, gas stations, libraries, etc.

**AB 85 (Weber) Dem**

- Social determinants of health: Upon appropriation of funding by Legislature, would require insurance coverage for screening and for follow-up by community health workers, peer support specialists, lay health workers, community health representatives, or social workers.

### **AB 315 (Bauer-Kahan) Dem**

- False advertising: abortion: Makes it a crime to falsely advertise pregnancy services.

### **AB 325 (Reyes) Dem**

- Human services: noncitizen victims. Prohibits cancellation of health and social services to victims of trafficking or domestic abuse when visas are not renewed.

### **AB 571 (Petrie-Norris) Dem**

- Medical malpractice insurance: Prohibits provider insurance cancellation or surcharge for performing reproductive (including abortion) or gender-affirming services

### **AB 1057 (Flora) Rep**

- California Home Visiting Program: Establishes the voluntary home visitation program, currently established only administratively, as an official public health program listed in the Health and Safety Code, for which the state would provide funds to local health departments.

### **AB 1089 (Gipson) Dem**

- Firearms: Restricts 3-D printing of firearms; prohibits such printers if primary purpose is firearm manufacture. Existing law requires licensure if more than 3 firearms manufactured/year. Support amendment to require license if even one firearm manufactured, but this is already in bill as written, if manufactured by 3-D printing.
