CAPM POS – Position of the CAPM Board

LEGISL.– Results of legislative process (both houses)

GOVERNOR – Signing into law or vetoing of bills passed by legislature

Passed – bill passed both houses and sent to Governor

Failed – bill failed to pass both houses of legislature, not sent to Governor; some might be revived 2026

Withdrawn – author cancelled bill to avoid defeat in committee; could be reconsidered 2026

Sig – Governor signed bill into law

Vet – Governor vetoed bill
